LICENCE under the MOTOR VEHICLE SPORTS (PUBLIC SAFETY) ACT, 1985

IN pursuance of the Motor Vehicle Sports (Public Safety) Act 1985, I hereby grant C1 Speed P/L a licence for the Albion Park Rail Indoor Karts Motor Vehicle Racing Ground at 176 – 178 Princess Highway, Albion Park Rail subject to the provisions of that Act and the Motor Vehicle Sports (Public Safety) Regulation 2010.

THIS licence shall remain in force from (and including) the date of issue to (and including) 30 June, 2014, unless it is sooner cancelled or suspended.

THIS licence is issued subject to the conditions specified on the annexure.

THIS licence is only valid when events are conducted under the auspices of a Controlling/Sanctioning Authority or public risk liability insurance is in place and maintained as stated in clauses 1, 2 and 32 and is issued subject to the conditions specified on the annexure.

CONDITIONS

(1) Insurance required

Before the ground is used for motor vehicle racing or practice, the licensee is to provide the Director-General with evidence satisfactory to the Director-General that public risk insurance cover has been effected in respect of all claims arising out of each meeting at the ground. The State of New South Wales and Sport and Recreation must be noted on the insurance policy as an insured or interested party for their respective rights and interests.

(2) Insurance to be maintained

The licensee must maintain the insurance cover during the currency of the licence and notify the Director-General immediately on receipt of any advice from the insurer of intention to cancel the policy.

(3) Notice of meeting to police and ambulance service

The licensee must, at least 14 days before the holding of a race meeting at the ground, give notice in writing of the intended meeting to each of the following:

- (a) the officer-in-charge of the police station nearest to the ground,
- (b) the officer-in-charge of the ambulance station nearest to the ground.

(4) Fire-fighting appliances

The licensee must provide and maintain serviceable fire-fighting appliances as required by the Minister for the type of motor vehicle racing conducted at the ground.

(5) Maintenance of safety fences

The licensee must maintain all fences and other safety devices constructed at the ground in such condition as is necessary to ensure that they provide the protection they are designed to provide.

(6) Directions for additional safety measures

The licensee must comply with any written direction of the Minister served on the licensee requiring the construction of a fence or any other safety device at the ground to such specifications as are stated in the direction.

(7) Location of pit area or paddock area

The licensee must comply with any written direction of the Minister served on the licensee requiring that the location of a pit area or paddock area be changed.

(8) Plan of ground to be displayed

The licensee must keep the licence for the ground displayed in a position accessible to all patrons together with a copy of the plans of the ground showing the location of the various facilities at the ground, including any paddock and pit areas and any unauthorised areas.

(9) Toilet facilities

The licensee must provide and maintain sanitary accommodation for both sexes in such quantity and at such a standard as are satisfactory to the local Council.

(10) Inspection of ground

The licensee must ensure that access is available to all parts of the ground:

- (a) to any police officer on duty, and
- (b) to any person authorised to inspect the ground by the Minister,

who desires to carry out an inspection for the purpose of ascertaining whether the licensee is complying with this Regulation and the conditions of the licence.

(11) Reporting of serious accidents

If, during a race meeting at the ground, a person dies or is injured in a way that requires medical attention, the licensee must give an accident report (in a form approved by the Director-General) to the Director-General and the officer-in-charge of the nearest police station as soon as is reasonably practicable.

(12) Notification of change in ownership of ground

The licensee of a ground must notify the Director-General immediately of any change in the person or persons who have the right to immediate possession of the land on which the ground is situated.

(13) Notification of alterations to configuration of track

The licensee must obtain the prior approval of the Director-General for any alteration to the configuration of the racing track at the ground.

(14) Notification of permit/approval or authority for event

The Controlling/Sanctioning Organisation/Licensee/Club/Promoter must ensure that the Director-General is provided with a copy of the Permit/Approval or Authority to conduct an event, at least one working day prior to the conduct of any event.

(15) Notification of compliance for event

The Controlling/Sanctioning Organisation/Licensee/Club/Promoter must ensure that the Director-General is provided with a copy of the Steward/Authorised person's report of the conduct of the event within 10 working days from the conclusion of any event.

(16) Event and facility emergency management plan

To ensure that any user of the licensee's facility integrates into the facilities emergency management plan.

- (17) All access points to the race track and/or pit lane area must be secured at all times by a key or padlocked gate, padlocked chain or physically manned by authorized persons.
- (18) All races and/or events are to be conducted in accordance with the minimum requirements of the Work, Health and Safety Act 2011 and Standards Australia.
- (19) Any reasonable request or direction given by NSW Police must be strictly observed and adhered to in full.
- (20) All areas prohibited to spectators to be signposted accordingly.
- (21) Spectators shall be prohibited from entering upon those areas of the motor vehicle racing ground which are not protected by safety fencing and spectator control fencing. These areas shall be suitably signposted.
- (22) Marshals to be provided at the entrance and exit points to the pit area to prevent the entry of unauthorised persons.
- (23) Sufficient marshals to be provided around the remainder of the motor vehicle racing ground to ensure the proper conduct of racing.
- (24) Entry to the pit, paddock and support paddock areas is restricted to competitors, support crew, officials and those persons authorised.
- (25) The pit areas shall be separated by spectator control fencing from those areas which are set aside for such use by spectators.
- (26) The motor vehicle racing ground shall be used for the racing of four wheeled vehicles commonly known as karts.
- (27) The licensee must ensure that all events conducted by a non affiliated/non recognized Sanctioning/Controlling Authority are conducted to the minimum safety specifications, officiating and ethical standards of the equivalent recognized Sanctioning/Controlling Authority.
- (28) Motor vehicle racing may be conducted in an anti-clockwise direction only.
- (29) Sufficient security officers must be employed and deployed accordingly.

- (30) Any conditions or requirements imposed by local government authorities must strictly adhered to.
- (31) A qualified first aid officer must be on duty at all times whilst the circuit is in use.
- (32) The licensee must ensure that at all times, a current certificate of currency as stipulated in clause (1) of this licence is in effect by the organiser of any non Karting NSW affiliated race/event and a copy of this policy is forwarded to Sport and Recreation prior to the conduct of any race/event.
- (33) No person:-
 - (a) under 16 years of age shall ride, drive or be in charge of any four wheeled motor vehicle on the licensed motor vehicle racing ground;
 - (b) under 16 years of age shall be -
 - (i) a mechanic; or
 - (ii) a member of the crew

of any four wheeled motor vehicle taking part in a race or event on the licensed motor vehicle racing ground.

(34) A maximum of 9 (nine) karts are permitted on the track at any one time.
