Terms and conditions

- By accepting the accompanied quotation you acknowledge the following terms and conditions.
- 2. In these terms and conditions,
 - "We" means Faces Makeup and Hair or any person trading in the capacity as a stylist of Faces Makeup and Hair;
 - "You" means the person requests our services;
 - "Stylist" means any person trading in the capacity as a stylist of Faces Makeup and Hair.

Trials

- 3. A trial booking can only be secured by a deposit of AUD \$100. We are not obliged to keep your appointment without a deposit. From time to time we may honour your trial booking without a deposit due to the lack of time for electronic transfer clearance. However, you acknowledge that we provide our trial service without a deposit on a goodwill basis and not as an obligation.
- 4. Unless Clause 9 is engaged, the deposit is strictly non-refundable under any circumstance.
- 5. You may change the date and/or time of your trial appointment if and only if you notify your stylist by email or SMS at least 48 hours in advance. The deposit can be transferred to a rescheduled appointment as agreed by you and your stylist. The deposit will not be refunded if there is no mutually convenient time to reschedule the appointment.
- 6. The appointment may only be rescheduled once for each trial booking. If you are unable to attend the rescheduled booking, your deposit may not be refunded.
- 7. We may refuse to reschedule your appointment if you notify us less than 48 hours prior to the appointment. Your deposit may not be refunded.
- 8. You may cancel your trial appointment. The deposit will not be refunded.
- 9. Booking a trial does not guarantee that your wedding day will be reserved for you unless we received a separate deposit for the wedding day. However, you will be notified before your trial if your stylist is no longer available on your wedding day. We will refund the deposit for your trial in this circumstance.
- 10. We will do as many styling for you as we can in the trial session (90 minutes for makeup, 90 minutes for hairstyling). At the end of the trial session the quality of makeup and/or hairstyle will not be of photographic quality. You are required to make a separate booking for makeup and hair service prior to a professional photo-shoot session.
- 11. After the trial, we are not obliged to reserved your wedding day for you without a deposit and we are not obliged to notify you if your wedding day is no longer available.

Makeup application and hairstyling for special occasions and photo-shoot sessions

- 12. A special occasion or a photo-shoot makeup and hairstyling booking can only be secured by a deposit of AUD \$100. We are not obliged to keep your appointment without a deposit. From time to time we may honour your booking without a deposit due to the lack of time for electronic transfer clearance. However, you acknowledge that we provide our makeup and hairstyling service without a deposit on a goodwill basis and not as an obligation.
- 13. The deposit is strictly non-refundable under any circumstance.
- 14. The balance is due 14 days prior to the appointment.
- 15. An early morning surcharge of \$30 per hour per stylist is payable if your appointment is earlier than 7am.
- 16. A \$50 call-out charge is payable if your booking is under AUD \$300.
- 17. You are required to provide parking space for your stylist. If you are unable to do so, your stylist will use the closest parking facility available and you are required to reimburse all charges in relation to the parking.

- 18. For on-site re-touch service (apart from one-off re-touch service) you are required to provide transport for your stylist from your location to the site(s).
- 19. You may reschedule your appointment by one of the following ways:
 - Where the reason for rescheduling is unsuitable weather for photo-shooting, you
 must notify your stylist by SMS or phone call at least 4 hours before your
 appointment; or
 - b) Where the reason for rescheduling is not unsuitable weather for photo-shooting, you must notify your stylist by email or SMS at least 48 hours before your appointment.

In either case your deposit can be transferred to a rescheduled appointment as agreed by you and your stylist. The deposit will not be refunded if there is no mutually convenient time to reschedule the appointment.

- 20. We may refuse to reschedule your booking if your notification to reschedule is not made in accordance with Clause 19. Your deposit may not be refunded.
- 21. The appointment may only be rescheduled once for each booking. If you are unable to attend the rescheduled booking, your deposit may not be refunded.
- 22. You may cancel your appointment. The deposit will not be refunded.
- 23. We will provide only one makeup application and/or one hairstyling service in a single appointment. If you require us to provide multiple styles for you to choose from, you are required to make a trial booking prior to your photo-shoot makeup and hairstyling appointment.
- 24. If you had not have a trial appointment with us previously, you may indicate your preferred stylist(s) but we reserve the right to dispatch any stylist from our team for your appointment.

Bridal and bridal party makeup and hairstyling for wedding day

- 25. A wedding day booking can only be secured by a deposit paid at the rate of AUD \$100 per stylist. We are not obliged to keep your appointment without a deposit.
- 26. The balance is due 14 days prior to the appointment. We may refuse to provide service if the balance is not paid into the nominated bank account at least 10 working days prior to the wedding day.
- 27. To the extent allowed by the law, all payment towards the wedding day booking (including but not limited to deposit, balance and payment for cosmetics items) are strictly non-refundable under any circumstance.
- 28. You may not reschedule your wedding day booking.
- 29. An early morning surcharge of \$30 per hour per stylist is payable if your appointment is earlier than 7am.
- 30. A \$50 call-out charge is payable if your booking is under AUD \$300.
- 31. You are required to provide parking space(s) for your stylist(s). If you are unable to do so, your stylist will use the closest parking facility available and you are required to reimburse all charges in relation to the parking.
- 32. For on-site re-touch service (apart from one-off re-touch service) you are required to provide transport for your stylist from your location to the site(s).
- 33. If you had a trial appointment with us previously, the same stylist will be dispatched for your wedding day unless he or she becomes unavailable due to unforeseen circumstance.
- 34. If you had not have a trial appointment with us previously, you may indicate your preferred stylist(s) but we reserve the right to dispatch any stylist from our team on your wedding day.
- 35. We are not obliged to stay if we have completed our work before the estimated completion time. We may refuse to pose for any photograph. We may refuse to follow any instruction that is outside the scope of our makeup and hairstyling services.

Changes to booking

- 36. You may increase the number of services anytime, subject to the availability of our stylist(s).
- 37. You may not reduce the number of booked services if:
 - a) a balance payment has been made: or
 - b) you notify us less than 14 days prior to the wedding day.
- 38. If Clause 37 is not engaged, you may change the number of makeup application or hairstyling you have booked if and only if the number of stylists required will not be less than as originally requested. If you request a change to services so that one or more stylist(s)

- is/are no longer reasonably required, we may keep the portion of deposit paid for those stylist(s).
- 39. A change of time for your wedding day appointment may be refused if the stylists are not available.
- 40. The Principal Stylist does not accept appointments earlier than 7am under normal circumstance. If you change your appointment to a time earlier than 7am, other stylists may be dispatched subject to availability.
