ENVIRONMENTAL POLICY

Silvergums Property Services implemented an environmental policy back in 1998 when we began business. Since this time the Environmental Policy has been reviewed several times with changes being made when and where appropriate, to ensure that our views on environmental issues are treated with the utmost importance & respect.

WASTE MANAGEMENT

All litter & debris that is collected from each site is to be sorted into 3 separate compartments being, green waste, recyclable packaging bottles, plastics paper etc & non-recyclables. This is then taken to waste transfer stations, green waste is deposited for composting & or mulching, recyclables are deposited for recycling & non recyclables are put to land fill.

USE OF CHEMICALS

The most common chemical group used is Glyphosate; this chemical is used for weed management. At Silvergums we limit the use of chemicals such as Glyphosate with correct Horticultural techniques, mulching of gardens to correct depth & mulching around the base of trees, Etc. Organic (non chemical) fertilizers are used in most instances for lawn and garden nourishment.

Safety data sheets are supplied to employees & sub-contractors for each chemical used.

NOISE CONTROL

All machines are serviced & maintained to original specifications & are not to be modified. Additionally all machinery is used within the guidelines for working hours.

EROSION & SEDIMENT

All sediment is removed from dish drains & drainage sumps to prevent blockage. Advice is given to customers on erosion control to embankments, bare soil areas etc, by the use of plant materials or mechanical means. Kerb & gutters are cleaned of debris & litter, to stop waste being washed into stormwater.

AIR QUALITY

Our largest problem for air quality is dust due to use of mowing equipment. This is minimised by keeping lawns in a healthy state, limiting exposed areas etc. Exposed areas are seeded or if areas are unsuited for lawn they can be changed into gardens etc. Mowing is not carried out in adverse conditions eg. high wind.
