Premier Research Labs (PRL) was founded to deliver uncompromising quality and effectiveness by providing 100% non-toxic and effective products. In fact, PRL has achieved an industry first in creating quantum-state products based on quantum cellular resonance technology. Our products are free of toxic chemical tagalongs through the entire process, from conception to consumption: growing, harvesting, encapsulation, bottling and delivery to you.



### Premier Products With No Added Excipients

Excipients are highly questionable and often toxic tag-along chemicals or agents which are used in typical nutritional supplement manufacturing processes. However, PRL strives to produce products that are 100% excipient-free.

We guarantee that what you see on the label is exactly what is in our product: absolutely no undisclosed excipients, such as fillers, binders, artificial colors or other toxic tagalongs.

Many nutritional supplements contain potentially health-impeding excipients, sometimes listed under "Other Ingredients" on the label, or not listed at all – a *deceptive practice*. Ingredients such as magnesium stearate (an undesirable hydrogenated oil), silicon dioxide (the chemical term for common sand), natural flavors (a common term for toxic MSG, monosodium glutamate) are often used as fillers or flowing agents to help in the encapsulating process, or to disguise "off" or bland tastes in a product. These toxic, non-nutritive chemical agents have the potential to create health problems if consumed over time.

### 100% Solvent-Free Vegetable Capsules

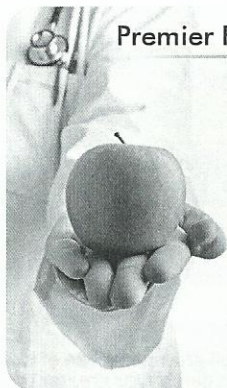
We strive to provide products that are made with 100% solvent-free vegetable capsules or vegetable-source gelatin caps. These capsules are superior to their solvent-based or gelatin counterparts and ensure a healthier, safer product for our customers. Sadly, other manufacturers often use inferior vegetable capsules (solvent-tainted) as well as tablets and animal-based gelatin capsules, all which can create serious problems if consumed over time.

By their nature, tablets need glues and binders (which typically test toxic) to hold their ingredients together. Animal-source gelatin capsules are hard to digest, temperature-sensitive, typically contain toxic preservatives in their shell and may carry the risk of prion exposure. In contrast, our 100% solvent-free vegetable capsules dissolve rapidly (regardless of temperature) and provide excellent absorption of nutrients.



### Manufacturing at the Quantum Level

PRL is a primary manufacturer that offers a full professional line of premier nutritional products and foods. Our state-of-the-art manufacturing facility located in Austin, Texas, is an FDA monitored facility that operates under current GMP (Good Manufacturing Practice) guidelines. Our products are manufactured in rooms with controlled temperature, humidity and dust conditions. Before each production run, our manufacturing equipment is cleaned and sterilized and released by an experienced quality control team. In addition, PRL strives to excel in state-of-the-art bioenergetic analysis and implementation. We offer periodic tours for practitioners to inspect our world-class facilities.

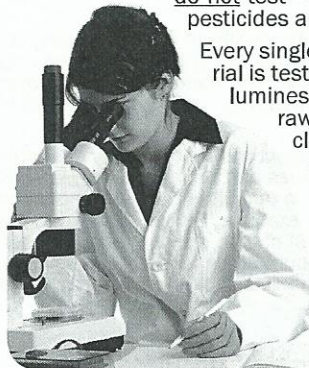

PRL conducts scientific laboratory testing of every incoming container of raw material and all finished products, as well as state-of-the-art QRA™ 4-polarity testing of all ingredients. PRL has pioneered the use of QRA™ 4-polarity testing to ensure the customer is consistently getting the best quality worldwide. In addition, we use the most advanced lab equipment and test methods, including HPCS (High Performance Crystal Spectroscopy) to assure the potency and reliability of every ingredient and to scan for many contaminants that other companies typically do not test — such as radiation, heavy metals, pesticides and excess moisture.



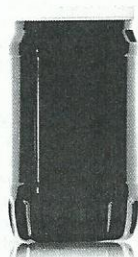

Violite® is our patent-pending, dark violet-colored, PET plastic bottle engineered to block the light frequencies from 450-720 nanometers, which create radiation damage to ingredients.
