#### BOOKINGS

Ultimate Games (Aust) Pty Ltd requires a 50% deposit of the total invoice amount to ensure your booking timeslot. The remaining booking fee must be paid within seven (7) days prior to the event date to secure your booking

#### INSURANCE

Ultimate Games (Aust) Pty Ltd brings a fully equipped gaming cinema to your event, no responsibility will be taken for loss or damage to any guests merchandise or property prior to, during, or after the event.

#### CANCELLATIONS

If cancellation is made within twenty one (21) days of the booking date, the total booking/hire fee will be forfeited. Cancellations greater than to the twenty one (21) days will incur a \$50.00 administration fee with the remaining fee refunded within seven (7) days.
