**The following is a warning, release of liability, assumption of risk & indemnity agreement between the renting party & Boomerang Bike Hire (BBH) or their agent.**

- Bicycles returned with damage greater than \$30 are subject to a repair fee based on the amount charged by a third party repairer. BBH retains the right to debit the Credit Card detailed below with the repair fee.
- It is the responsibility of the person hiring the bicycle to return all bicycles & equipment under all circumstances, & acknowledges that BBH does not provide a pick-up /rescue service. If the bicycle is lost, stolen or not returned, the full value of the bike (up to a maximum of \$2000) will be debited from the Credit Card detailed below.
- If locks, pumps, repair kits, bags or helmets are lost, stolen or not returned a \$10 fee per item will be debited from the credit card detailed below.
- If any puncture occurs during the hire period you are supplied with replacement tube & repair kit, use of this kit will not incur a fee.
- The bicycle will be securely locked when not being ridden.
- A helmet is included in the hire of the bicycle & must be worn when riding, as required by New South Wales law.
- The person hiring the bicycle must understand & accept that riding a bicycle can be hazardous & involves risks that may be injurious or fatal.
- Cycle path etiquette & road safety rules must be followed at all times. Lights are not provided thereby making the bicycles unsafe & illegal to ride after dark.
- BBH and/or its agents reserves the right to refuse to hire a bicycle to any person in its absolute discretion.
- The person hiring the bicycle agrees that BBH, its employees & agents are released from & indemnified against any claim for injury, loss or damage to the hirer, or to any other person or property, which are in anyway connected to participation in the use of the bicycle however caused. The person hiring the bicycle agrees to waive their right to present any legal claim or lawsuit against BBH regardless of how any damage, injury or death may have occurred, through negligence or any other manner considered through legal claim. The person hiring the bicycle also agrees that this contract shall be binding for themselves, their heirs, assigns, executors and personal representatives and administrators of their estate.
- There is a one-hour minimum charge applied to all hires.
- A person under 18 years of age may only hire a bicycle with the written consent of a parent or guardian. Consent is indicated by the signing of this form.
- If you leave personal property with us you do so at your own risk.
