Debt Recovery

Our focus at ADC Legal is to keep your business running as efficient and profitable as possible. We do this by ensuring that you are paid for the work you have done and are bad debtor free. The steps we take to achieve this include sending Legal Letters of Demands on a lawyer's letterhead, which in our experience will often lead to an immediate reply and payment of the debt. The greatest threat to debtors, including individuals and companies, is to receive a letter of demand from a law firm followed by a Claim/Complaint and Statement of Claim. In some cases, a Statutory Demand or Winding Up Notice may also be the best method in respect of debts owed by companies.

At ADC Legal, our letters of demand explain to debtor companies and individuals that if legal proceedings are required to be instituted against them, that those proceedings will include a claim for interest on the debt and a claim for the costs of the proceedings to be paid by the debtor. In our experience our letters of demand have significant prospects of success. If they are not successful we will try all means possible to locate and contact the debtor to recover 100% of your debt. As a last resort, we will then recommend to proceed immediately with formal legal proceedings.

Commercial & Civil Litigation

ADC Legal conducts matters ranging from simple civil debt recoveries between individuals or small businesses; all the way up through motor vehicle claims and insurance claims recovery and defences; to commercial supply and breach of contract claims and defences, and as far up as corporate restructuring and multi-million dollar land acquisition litigation.

Pricing

(a) Non-Litigation

A legal letter of demand will be \$50.00 plus GST.

If ADC Legal use time costing (in particular matters), we will charge an hourly rate for our legal services.

A flat rate will be applied for Principals and Senior Lawyers, a more affordable rate for Solicitors, and a competitive hourly rate for paralegals.

(b) Litigation

The costs outlined below are our special rates for recovery and litigation work.

Professional fees and outlays for undefended debt recovery matters in the Magistrates Court of Victoria and straightforward enforcement processes including bankruptcy and winding up are as per our Fees Schedule listed in our Costs Agreement. This schedule reflects the Court's approved scale of costs for this work. A schedule of costs for New South Wales, Queensland and other jurisdictions can also be provided. Any other legal work performed outside the pre-quoted list of steps in litigation can be quoted upon request.

By charging at scale our clients get the certainty of knowing what their costs will be up front in most cases.



Professional fees and outlays for defended matters in the Magistrates Court of Victoria, Local Court of New South Wales and the Magistrates Court of Queensland will be according to time costing at the rates stated above. ADC Legal will provide an estimate of the likely costs of the litigation as soon as the matter is defended. In addition to our stated objective to provide value for money, we always aim to ensure that fees charged are proportionate to the claim in dispute.
