Albany Mapping & Surveying Services (**AM&SS**) are a Licensed Consulting Surveying practice based in Albany Western Australia. **AM&SS** was established in the year 2000 by Principal Licensed Surveyor John A Jamieson to service a growing need for specialised surveying solutions to solve complex land tenure problems and perform difficult engineering surveys in challenging environments. **AM&SS** have four fully equipped survey crews with the latest in precise Robotic Total Stations, GNSS RTK receivers and Digital Levels. They are well supported by technical and office staff who utilise powerful surveying and engineering design and drafting software to deliver the highest quality information possible in a format tailored to each client's needs.

Christopher Stan-Bishop joined **AM&SS** in 2010 bringing with him specialised technical skills in precise positioning equipment and computerised surveying, automated processing and Computer Aided Design along with team and project management skills developed managing survey teams for large scale construction projects in the oil and gas offshore industry. Due to the remote nature of offshore surveying, practical problem solving was often required to overcome challenging environments with limited resources. Communicating and liaising with stakeholders effectively was very important to ensure projects were completed safely, accurately and in a timely manner. Christopher was inducted as a 50% partner of **AM&SS** in July 2012 to continue to grow and develop the services offered by **AM&SS** and continue the cutting edge innovative thinking and solutions that are provided.

John A Jamieson began his surveying training in 1961 and achieved his practising cadastral license by 1965. Undertaking many remote surveying jobs working as a government contract surveyor, John met and learnt about many of the surveyors who developed and originally surveyed and subdivided Western Australia giving him unique knowledge of the land tenure system and ground marks in Australia. In 1968 John Co-founded McKimmie Jamieson & Partners Pty Ltd (now MAKJAP Pty Ltd) in the Perth CBD rapidly growing the business to nationwide offices and capability in all facets of surveying. John took an opportunity in 1974 to work on ground breaking construction projects in the North Sea which followed on to commissions in Europe, Africa and the Middle East undertaking large scale construction projects and survey campaigns while opening offices and expanding the Sir Robert McAlpine & Sons Limited and later the Royal Bos Kalis Westminster Group n.v. John returned to Australia in 1988 and continued his work with McKimmie Jamieson & Partners until 1989 when he decided to have a sea change. Continuing his work as a Surveyor, John has been servicing the needs of the Great Southern since.
