## Terms & Conditions

**Please read and sign below that you have understood and agree to the Terms and Conditions of Hire.**

1. It is a condition of this application that you read and understand the terms set out in this application. Limoso Limousines can make changes to the terms and conditions and the current terms and conditions are applicable at the time of the booking
2. All details should be completed on this application including mandatory security credit card details and a contact number for the credit card holder regardless of your chosen method of payment. All details regarding the booking must be confirmed no less than seventy-two (72) hours prior to the booking. All vehicles are subject to availability and a booking is only approved if a confirmation reference number has been received and a 50% deposit has been paid.
3. All weddings are calculated from the first point of pick up to the final point of drop off within the metropolitan area of our local office. A minimum of two (2) consecutive hours are required on all wedding bookings in the Brisbane Region and a minimum of three (3) hours outside the Brisbane region plus an additional 2hr re-location fee.
4. A booking fee of 50% is required with the application to confirm bookings. The balance of payment is required no less than **thirty (30) days** prior to the planned wedding date. Weddings less than 40 days from wedding date require full payment.
5. Please note that any overtime after the specified duration of the wedding will be charged in quarter hour intervals at the current hourly rate for each vehicle. This will be charged with the credit card provided on the application.
6. All prices are subject to change without prior notice, however if a booking has been confirmed and a deposit has been received, then the agreed rate will apply. Overtime will be charged at the rates current to the day.
7. A cancellation fee of fifty percent (50%) of the total charter plus a \$50 admin fee per vehicle will apply if the bookings are cancelled within ninety (90) days of the wedding date. A full refund of monies will be given for cancellations notified more than ninety one (91) days prior to the planned wedding date, less an administration fee of fifty dollars (\$50.00) per vehicle.
8. All prices quoted are inclusive of GST and/or relevant taxes where applicable.
9. All vehicles are supplied with white ribbons and decorations such as tulle and silk floral arrangements. Should you require specific decorations that are not available in our selection then those items will need to be supplied by the customer forty-eight (48) hours prior to the wedding date. In the case of coloured ribbons for vehicle fronts a minimum of eight (8) metres is required.
10. The Customer agrees that Limoso Luxury Transport will not be liable for any damages due to delays or non-performance arising from issues outside of Limoso's control. Limoso will provide a similar service if possible.
11. The customer is liable and accepts full responsibility for any damages and breakages where they are at fault. This does not include car accidents or weather damage nor damages or breakages caused by the driver.
